AND IT IS SO ORDERED.



COMMISSIONER PCT. 1


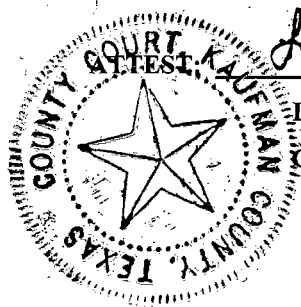

