MOTION TO ADOPT FY 2007 - 2008 TAX RATE

There came on to be considered a motion as follows, "I move that property taxes be increased by the adoption of a Tax Rate of: General Operating Fund - .460, Road & Bridge Maintenance Fund - .0680, I & S Rate - .0335; Total Tax Rate - .5615. THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE AND THE TAX RATE WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,00 HOME BY APPROXIMATELY \$ (0.70)".

A motion was made by Commissioner Jim Deller and seconded by Commissioner Ray Clark. Whereupon said motion was put to a vote and motion carried.






